Day of Show entries: \$8.00 per animal, per show

Ear Changes: (for same class) \$1.00, (for different class, variety, sex, etc.) \$8.00

### General Show Information

**NO COMMENT CARD SHOW.** No smoking permitted on the fairgrounds (fair management rule), and no dogs (other than service animals) permitted on the fairgrounds.

Please use the generic entry form provided, or follow this link: **OLRCB Generic entry form.** When submitting email entries, make sure to provide all information requested by the entry form.

Checks should be made out to: **Crazy 8 RCB.** Email entries must contain all information on entry form. Partially filled out entries may be subject to return w/o entry to the show.

### Awards

Ribbons will be presented to First through Third place winners; Rosettes for BOB and BOS; BIS - \$50.00, and RIS - \$25.00.

### Show Rules

1. All rabbits must be permanently and legibly tattooed.
2. This is a carry cage show. All carriers must have leak-proof bottoms.
3. **Judging will begin 8:00 AM SHARP.** All official ARBA show rules will be in effect. Animals entered in fur class must also be entered in breed class.
4. Exhibitors are responsible for carrying their own animals to the table.
5. The show superintendent may remove any animal showing signs of illness from the show room.
6. Crazy 8 Rabbit & Cavy Breeders reserves the right to add, cancel, or substitute judges as necessary.
7. By submitting an entry, the exhibitor agrees to pay entry fees, regardless if animals are shown or not.
8. Crazy 8 Rabbit & Cavy Breeders will not be responsible for any losses.
9. Children must be supervised (in line of sight) by an adult (18yrs or older) at all times.
10. No animals other than rabbits, cavies or certified service dogs as defined under Federal Department of Justice Guidelines, will be permitted in the showroom. See also CCF website for a specific policy <http://www.clackamas.us/fair/> at the bottom of the page under the mission statement.
11. The Clackamas County Event Center is a Smoke-Free facility. There is no smoking allowed anywhere on the grounds or buildings.
12. Filing an entry indicates acceptance of these rules.
